Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and a notice of default has been recorded pursuant to Section 86.735(3) of Oregon Revised Statutes; the default for which the foreclosure is made is grantor's failure to pay when due the following sums:
 Real Property Taxes, due for the years of 1979-1980 in the amount of \$3.89 plus interest, 1980-1981 in the amount of \$59.87 plus interest, 1981-1982 in the amount of \$59.09 plus interest, 1982-1983 in the amount of \$82.00 plus interest, 1983-1984 in the amount of \$91.36 plus interest, and 1984-1985 in the amount of \$105.61 plus interest, and subsequent amounts due under the terms and provisions of the Note and Trust Deed.

By reason of said default the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following, to-wit:
