 2 McMinnville, Oregon, a cooperative association organized under the laws of
 3 Oregon, Assignor, in consideration of Ten Dollars to it paid by Herbert H. Imel
 4 and Myrtle M. Imel, husband and wife, Assignees, does by these presents re-assign
 5 and transfer to said Assignees all of the Assignor's right, title and interest
 6 in and to that certain contract dated July 11, 1964, wherein said Assignees
 7 agreed to sell and L. L. Stamper and Lillian M. Stamper, husband and wife, agreed
 8 to purchase the following described property in Klamath County, Oregon:

9 The South one-half (S½) of Lots 330 and 331 in Block 111 of MILLS ADDITION
 10 to the City of Klamath Falls, Oregon, EXCEPTING THEREFROM the Easterly 25
 11 feet of Lot 330 in Block 111 of MILLS ADDITION;

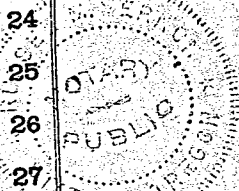
12 which said contract was assigned by said Herbert H. Imel and Myrtle M. Imel,
