THIS CONTRACT, Made the 15 day of June, 1985, between  
Wilma M. Stewartof the County of Klamath and State of Oregon, hereinafter called the  
seller, and Earl and Winifred Rambusch, Husband and Wifeof Klamath and State of Oregon of the County  
WITNESSETH, That in consideration of the stipulations herein contained and the payments to be made as  
hereinafter specified, the seller hereby agrees to sell, and the buyer agrees to purchase, the following described real  
estate, situate in the County of Klamath, State of Oregon, to-wit:Lot Twenty (20) in Block Six, Jack Pine Village, in the  
County of Klamath, State of Oregonfor the sum of Eighteen Thousand and no/100-----! Dollars (\$ 18,000.00 )  
on account of which One Thousand Three Hundred and no/100-----Dollars (\$ 1,300.00 )  
is paid on the execution hereof (the receipt of which is hereby acknowledged by the seller), and the remainder to be  
paid to the order of the seller with interest at the rate of 9 % per cent per annum from 1 Nov. 1  
1985, on the dates and in amounts as follows:Aug. 85 - Sept. 85 - Oct. 85 - Nov. 85. principal payments  
of \$100.00 each starting Dec. 1; 1985 payments of \$205.11  
Also the month of Nov. 1985 a principal payment of \$2,300.00  
to be made.This instrument does not guarantee that any  
particular use may be made of the property  
described in this instrument. A buyer should  
check with the appropriate city or county  
planning department to verify approved uses.

The buyer warrants to and covenants with the seller that the real property described in this contract is

\*(A) primarily for buyer's personal, family, household or agricultural purposes,

(B) for commercial, industrial, or other business purposes.

Taxes for the current tax year shall be prorated between the parties hereto as of the date of this contract. The buyer, in consideration of the premises,  
hereby agrees to pay all taxes hereafter levied and all public and municipal liens and assessments hereafter lawfully imposed upon said premises, all promptly  
and before the same or any part thereof become past due, that he will keep all buildings now or hereafter erected on said premises insured in favor of the seller  
against loss or damage by fire (with extended coverage) in an amount not less than \$18,000.00 in a company or companies satisfactory to seller,  
and will have all policies of insurance on said premises made payable to the seller as seller's interest may appear and will deliver all policies of insurance on said  
premises to the seller as soon as insured. All improvements placed thereon shall remain, and shall not be removed before final payment be made for said above  
described premises.

The seller agrees that at his expense and within \_\_\_\_\_ days from the date hereof, he will furnish unto buyer a title insurance policy insuring (in an amount equal to said purchase price) marketable title in and to said premises in the seller on or subsequent to the date of this agreement, save and except the usual printed exceptions and the building and other restrictions and easements now of record, if any. Seller also agrees that when said purchase price is fully paid and upon request and upon surrender of this agreement, he will deliver a good and sufficient deed conveying said premises in fee simple unto the buyer, his heirs and assigns; free and clear of encumbrances as of the date hereof and free and clear of all encumbrances since said date placed, permitted or arising by, through, or under seller, excepting, however, the said easements and restrictions and the taxes, municipal liens, water rents and public charges so assumed by the buyer and further excepting all liens and encumbrances created by the buyer or his assigns.

But in case the buyer shall fail to make the payments aforesaid, or any of them, punctually and upon the strict terms and at the times above specified, or fail to keep any of the other terms or conditions of this agreement, time of payment and strict performance being declared to be of the essence of said agreement, then the seller shall have the following rights: (1) to declare this contract null and void, (2) to declare the whole unpaid principal balance of said purchase price with the interest thereon at once due and payable and/or (3) to foreclose this contract by suit in equity, and in any of such cases, all the right and interest hereby created or then existing in favor of the buyer derived under this agreement, shall utterly cease and determine, and the premises aforesaid shall revert and re-vest in the seller without any declaration of forfeiture or act of re-entry, or without any other act by seller to be performed and without any right of the buyer of reclamation or compensation for money paid or for improvements made as absolutely fully and perfectly as if this agreement had never been made.

The buyer further agrees that failure by the seller at any time to require performance by the buyer of any provision hereof shall in no way affect seller's right hereunder to enforce the same, nor shall any waiver by said seller of any breach of any provision hereof be held to be a waiver of any succeeding breach thereof or as a waiver of the provision itself.

The true and actual consideration paid for this transfer, stated in terms of dollars, is **\$18,000.00**. However, the actual consideration consists of or includes other property or value given or promised which is \_\_\_\_\_ the whole consideration (indicate which).<sup>(1)</sup>

In case suit or action is instituted to foreclose this contract or to enforce any provision hereof, the losing party in said suit or action agrees to pay such sum as the trial court may adjudge reasonable as attorney's fees to be allowed the prevailing party in said suit or action and if an appeal is taken from any judgment or decree of such trial court, the losing party further promises to pay such sum as the appellate court shall adjudge reasonable as the prevailing party's attorney's fees on such appeal.

In construing this contract, it is understood that the seller or the buyer may be more than one person or a corporation; that if the context so requires, the singular pronoun shall be taken to mean and include the plural, the masculine, the feminine and the neuter, and that generally all grammatical changes shall be made, assumed and implied to make the provisions hereof apply equally to corporations and to individuals.

This agreement shall bind and inure to the benefit of, as the circumstances may require, not only the immediate parties hereto but their respective heirs, executors, administrators, personal representatives, successors in interest and assigns as well.

**IN WITNESS WHEREOF**, said parties have executed this instrument in duplicate; if either of the undersigned is a corporation, it has caused its corporate name to be signed and its corporate seal affixed hereto by its officers duly authorized thereunto by order of its board of directors.
