A hearing was held on this matter on May 8, and June 12, 1985, pursuant to notice given in conformity with Ordinance No. 45.2, Klamath County, before the Klamath County Board of Commissioners. 5 The applicant was represented by Dru Hobbs. There is no timber management in the area, nor are any other forest uses defined by Goal 4 established on or adjacent to 5 6 7 A spetic system for the property would be subject to review 4. and approval by the Klamath County Health Department. 8 9 5. The property is within the Chiloquin-Agency Lake Fire 10 District, with fire stations at Chiloquin and Agency Loop Road, 11 approximately 3½ miles away. 12 6. The Conditional Use Permit is granted subject to the 13 following condition: 14 CONDITION: 15 The development for the two parcels is to be clustered a. and to be located on the soils that are least agriculturally 16 17 productive. 18 CONCLUSIONS OF LAW: 19 The proposed use is conditionally permitted in the zone 1. 20 within which it is proposed to be located. 21 The location, size, design, and operating characteristics 2. 22 of the proposed use are in conformance with the Klamath County 23 Comprehensive Plan. 24 The location, size, design, and operating characteristics з. 25 of the proposed use will be compatible with and will not have a 26 significant adverse effect on the appropriate development and 27 use of abutting property and the surrounding neighborhood. 28 The granting of this Conditional Use Permit is consistent C.U.P. 14-85 Page 2
