8 WHEREAS, the Board finds that the project is in compliance
9 with the Klamath County Comprehensive Plan acknowledged by the
10 Land Conservation and Development Commission pursuant to ORS
11 Chapter 197, and

12 WHEREAS, the Board finds that the project complies with the
13 provisions of the Overall Economic Development Plan, and

14 WHEREAS, ORS 280.330 requires, before the issuance of revenue
15 bonds by the State of Oregon, that the governing body of the
16 County endorse the project, and

17 WHEREAS, the Board finds that the completion of this expan-
18 sion in the Klamath Falls area of Klamath County would be in the
19 best interests of the citizens of Klamath County,

20 IT IS HEREBY RESOLVED:

21 1. That Klamath County requests the Economic Development
22 Commission and the State of Oregon to assist in the financing of
23 the expansion project within Klamath Falls in Klamath County,
24 through the issuance of revenue bonds secured by the improvements
25 as provided by ORS 280.310 to ORS 280.390.

26 2. That the Chairman of the Klamath County Board of Commis-
27 sioners be authorized to sign and act for the Board in any future
