11 Upon application of the plaintiffs and it appearing to the Court  
12 that on June 14, 1985, the Court made and entered herein its Inter-  
13 locutory Decree entitled, Order of Default and Judgment, requiring the  
14 defendant, Carol Krieger, Inc., an Oregon corporation, dba Wrigley  
15 Properties to pay to plaintiffs, through the Clerk of the Court, certain  
16 sums of money within fifteen (~~15~~) days from the date of said Order of  
17 Default and Judgment, or otherwise forfeit and be foreclosed of all  
18 of their interest in the real property described therein and to the  
19 money heretofore paid by any defendants on the purchase price of said  
20 property; and

21 It further appearing to the Court that the defendant, Carol  
22 Krieger, Inc., an Oregon corporation, dba Wrigley Properties has  
23 failed to pay said money and that the time for so doing has now expired  
24 and that plaintiffs are now entitled to a final decree of strict  
25 foreclosure, and the Court being advised in the premises,

1       1. That the defendant, Carol Krieger, Inc., an Oregon corporation,  
2       dba Wrigley Properties, is hereby forever strictly foreclosed of all  
3       interest in the following real property:

4       A tract of land situated in the NW1/4SW1/4 of section 7,  
5       T38S, R9EWM, Klamath County, Oregon, being more particularly  
6       described as follows:

7       Beginning at the W1/4 corner of said section 7; thence

9       Highway 97 (Dalles-California Hwy); thence S11°36'E, along


