

Description for Pine Grove Irrigation District Canal
easement through First Addition to Shield Crest Sub-
division.

A strip of land 50.00 feet in width, being 15.00 feet on the easterly and northerly side of centerline and 35.00 feet on the westerly and southerly side of the centerline of the Pine Grove Irrigation District canal in the West one-half of Section 8, T.39S., R.10E., W.M., Klamath County, Oregon; said strip of land being more particularly described as follows:

Beginning at a point on the north-south centerline of Section 8, T.39S., R.10E., W.M. from which point the 1/4 Section corner common to Sections 5 and 8 bears N 00°03'03"E 3047.46 feet distant; thence, running parallel to and 15.00 feet distant at right angles from, the centerline of the Pine Grove Irrigation District canal, N26°34'45"W 515.70 feet; thence N10°42'43"W 522.71 feet; thence 65.78 feet along the arc of a 71.25 foot radius curve to the left, of tangency of which bears N25°22'46"W 63.47 feet; thence 120.45 feet along the arc of a 218.00 foot radius curve to the left, the long chord of which bears N67°39'25"W 118.92 feet, to the point of tangency of said curve; thence N83°29'08"W 35.00 feet; thence S48°54'31"W 72.63 feet; thence S35°24'08"W 146.63 feet to a point on the south line of the NW_{1/4}NW_{1/4} of Section 8, said point being the southwesterly end of this easement; thence S89°22'22"E 60.87 feet to a point which is 35.00 feet distant from, at right angles to the centerline of said Pine Grove Irrigation District canal; thence, parallel to said centerline, N35°24'08"E 105.99 feet; thence N48°54'31"E 58.78 feet; thence N66°56'22"E 136.52 feet; thence N83°08'57"E 532.53 feet; thence S83°29'08"E 29.14 feet; thence 92.82 feet along the arc of a 168.00 foot radius curve to the right, the long chord of which bears S67°39'25"E 91.65 feet to the point of tangency of said curve; thence S51°49'43"E 165.42 feet; thence 19.62 feet along the arc of a 21.25 foot radius curve to the right, the long chord of which bears S25°22'46"E 18.93 feet to the point of tangency of said curve; thence S01°04'12"W 240.16 feet; thence S00°14'27"E 621.92 feet; thence S10°42'43"E 534.26 feet; thence S26°34'45"E 622.39 feet to a point on the north-south centerline of Section 8; thence N00°03'03"E 111.56 feet to the point of beginning.
