I, LOVIE M. TUPPER, being of sound mind and will, and wishing to provide for the testamentary disposition of My assets, do hereby declare this to my last Will and Testament, and do hereby revoke all other Wills and Codicils that I may have made.

I declare that I am not married, my most recent husband, BRUCE TUPPER, having died in 1978. I have children, whose names are as follows: JAMES PEREZ, LOVIE L. PEREZ, PAUL L. LINDSEY, VIETTA L. (LINDSEY) LOWE, BRAD L. LINDSEY, MARK L. LINDSEY, TEREZ L. LINDSEY, and ANGELO E. TUPPER.

II.

Only two of my said children are minors, and I therefore wish to make them the beneficiaries of my will, to provide for their present and future needs. Also, many of the assets in my estate have been derived directly or indirectly from my late husband, BRUCE TUPPER, who especially loved and cared for these two minor children, one of whom was his own son. Therefore, I devise all my property, both real and personal, and wherever situated, and in which I may have an interest at the time of my death, including any property over which I may have a power of appointment, and subject to the trust provisions of this Will, as follows:

Said trustee shall hold these estate shares in trust separately for the maintenance, care, and benefit of the respective beneficiaries, and shall have discretion to the fullest extent of the law in trust administration, except that the assets, and shares thereof, specifically devised shall not be sold or otherwise disposed of, except in extreme necessity, with the real property and interests devised therein, at 3027 N.E. 9th, Portland, Multnomah County, Oregon to be the last to be disposed of, if at all.

J appoint DELLA MAE HARPER, of Tucson, Arizona, as Personal Representative of my estate.
