This matter came on for a hearing before the Klamath County Board of Commissioners on September 11, and October 9, 1985, in 5 the Klamath County Commissioners' Hearing Room. The hearing was held pursuant to notice given in conformity with the Land Development Code and related ordinances. The applicant and Planning Department staff were present, as well as legal counsel. 9 The Board of Commissioners, after reviewing the evidence, 10 exhibits, and testimony presented, made the following Findings of 11 Fact: 12

FINDINGS OF FACT:

The applicant requested a Conditional Use Permit to 14 1. allow a non-farm parcel and kennel on 1.79 acres in the EFU-C 15 (Exclusive Farm Use-Cropland) zone. 16

The property is generally located south of State Highway 17 2. 140 and approximately one half mile west of Tingley Lane, and is 18 more particularly described as Tax Lot 500 located in Section 29 19 of Township 39, Range 9. 20

The plan designation is Agricultural, with the zoning 21 3. being EFU-C. Adjacent zoning and/or surrounding zoning is EFU-C. 22 The property consists of 1.79 acres, is rectangular in 23 4. shape, and consists of a kennel for shelter of animals. 24

Access to the property will be via Miler Island Road, 25 5. known as State Highway 420. This highway appears to be able to 26 handle the kind of traffic that will be generated at that location 27 Sewer is provided to the property by septic tank, and 28 6.

1 the property is served by Pacific Power and Light. Site has an 2 existing well for water.

3 7. The 1.79 acre parcel is a portion of a 19.38 acre unit
4 that will be utilized as it presently is.

CONCLUSIONS:

5

6 1. The proposed use is compatible with farm use as defined
7 in this Code and consistent with the agricultural land use policy
8 adopted by the Legislative Assembly in ORS 215.243. The proposed
9 1.79 acre parcel does not have any effect on surrounding agricul10 tural uses.

The proposed use does not interfere seriously with
 accepted farming practices on adjacent land devoted to farm use
 since it does not use agriculturally productive land and is to
 be used solely for a non-farm dwelling and not for any other use
 which would affect accepted farming practices.

16 3. The proposed use does not materially alter the stability
17 of the overall land use pattern of the area, and access to the
18 property will not interrupt any overall land use pattern.

19 4. The parcel and the access to it have been designed so as
20 not to interfere with accepted farming practices on the surround21 ing land.

22 5. The use is conditionally permitted in the zone in which
23 it is proposed to be located.

6. The location, design, and operating characteristics of
the proposed use are in conformance with the Klamath County Compre
hensive Plan.

27 7. The location, size, design, and operating characteristics 28 of the proposed use will be compatible with, and will not adversely C.U.P. 34-85 Page 2

Applicant will need to landscape for noise. 4 5 Applicant will need to submit a plan for physical control 2. 6 of animals. 7 3. Applicant will put up sign to indicate no dumping of animals on premises without first contacting Humane Society. 8 9 4.
