I am a Foreclosure Specialist of U. S. National Bank of Oregon, beneficiary of that certain deed of trust in which Henry A. Rennee III and Cleta M. Renne, who took title as Henry Aloysius Renne III and Cleta Marie Rennee, as grantor, conveyed to Mountain Title Company, as trustee, certain real property in Klamath County, Oregon to secure the performance by said grantor of certain obligations. Said deed of trust was dated April 21, 1977, and recorded April 21, 1977, as book M-77 page 6857 in the Mortgage Records of Klamath County, Oregon. Thereafter on May 23, 1985 there was recorded as Book M-85 page 7667, of the Mortgage Records of Klamath County, beneficiary's notice of default and election to sell with respect to the performance of the obligations secured by said deed of trust. Thereafter said deed of trust was duly foreclosed by advertisement and sale and the real property covered by said deed of trust was sold at trustee's sale on October 9, 1985.

At no time during the three months and one day immediately prior to the date of said sale, and including the day thereof, was the property subject to the above deed of trust, or any interest therein, owned by a person in military service (as such term is defined in 50 USC App Section 511) who owned the property at the commencement of his period of military service (as such term is defined in 50 USC App Section 511) and who incurred the obligations secured by the deed of trust prior to his period of military service (as such term is

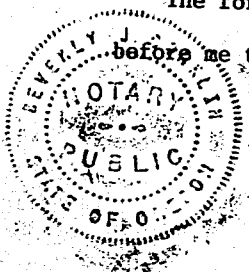
