CONCLUSION OF LAW: 13

Mr. Baker shall have 45 days from November 7, 1985, to 14 comply with the order herein dated September 11, 1985, which 15 requires him to remove all except two of the vehicles on his 16 property which are not in running condition, and/or parts of 17 such vehicles. 18

FINDINGS OF FACT: 19

The above Conclusion of Law was based on the following 20 Finding of Fact: 21
