- 3.3 The assessor or tax collector of the county in which the Property is located is authorized to deliver to the Lender a written statement of the property taxes assessed or owing at any time.

- 4.1 Grantor shall carry such insurance as the Lender may reasonably require. This shall include insurance on the Properly against fire, additional risks covered by a standard endorsement for extended coverage, and such other risks as may be specified by the Lender, including without limitation flood and war risks. (d) With respect to all or any part of the Property that constitutes personalty, the rights and remedies of a secured party under the Uniform

Commercial Code.

In furtherance of this right the Lender may require any tenant or other user to make payments of rent or use fees directly to the
