WHEREAS, GRANTOR and GRANTEE desire to amend said easement 5 in the manner hereinafter set forth;

NOW, THEREFORE, the parties hereto, do agree as follows:

- 1. Change the verbiage in condition No. 11 from "third parties engaged in logging operations and/or fire protection," to "licensees and permittees of GRANTEE."
  - 2. That, except as amended, all the terms and conditions of said easement shall be and remain in full force and effect.
