The West Half of the Southeast Quarter of the Northwest Quarter (W 1/2 of SE 1/4 of NW 1/4), in Section 13, Township 23 South, Range 9 East, Willamette Meridian, Klamath County, Oregon.

The East Half of the Southeast Quarter of the Northwest Quarter (E 1/2 of SE 1/4 of NW 1/4), Section 13, Township 23 South, Range 9 East, Willamette Meridian, Klamath County, Oregon.

It is expressly stated that it is the purpose of this Quitclaim Deed to extinguish that certain Easement heretofore granted and entered into between the Grantors herein Roger I. Helliwell, Personal Representative of the Estate of Robert L. Helliwell, deceased, under date 7 November 1980 recorded in Vol. M-80, at Page 22281, of the records of Klamath County, Oregon, as its Recorder's Instrument No. 92602, and that certain Easement heretofore granted and entered into between the Grantors herein and Roger I. Helliwell and Dorothy J. Helliwell, husband and wife, under date 7 November 1980 recorded in Vol. M-80, at Page 22283, of the records of Klamath County, Oregon, as its Recorder's Instrument No. 92603, insofar as those Easements affect the above-described real property.

This instrument will not allow use of the property described in this instrument in violation of applicable land use laws and regulations.
