MODIFICATION TO TRUST DEED

THIS MODIFICATION TO TRUST DEED is made as of October 3, 1985, under the following circumstances:

A. Redwood Theatres, Inc., a Nevada corporation, as Trustor, executed a Trust Deed dated July 1, 1985 and recorded on August 22, 1985, as Document No. 52410 Volume M85, Page 13337 in the Official Records of Klamath County, Oregon (the "Trust Deed"). The Trust Deed secures (1) two Promissory Notes of Trustor, each in the original principal amount of \$500,000; (2) performance by Trustor of its obligations under certain agreements referred to in the Trust Deed; and (3) payment by Trustor of any money advanced by Beneficiary to Trustor.

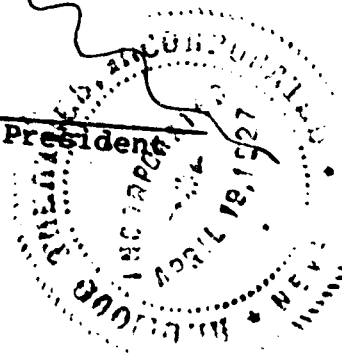
NOW, THEREFORE, the Trust Deed is hereby modified as follows:

The Trust Deed shall secure two additional Promissory Notes of Trustor payable to the order of Pacific Concessions, Inc., a California corporation. The first such Promissory Note is in the principal sum of \$600,000 and is dated October 3, 1985. The second Promissory Note is in the principal sum of \$200,000 and is dated November 1, 1985

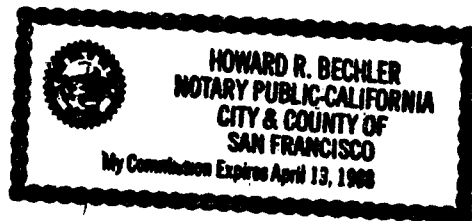
