NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by JOHN A. GUNNARSON, married man, as
sole and separate property PIONEER NATIONAL TITLE INSURANCE CO., as trustee,

The undersigned hereby certifies that no assignments of the trust deed by the trustee or by the beneficiary
