That the Notice stated the filing of the Petition, the name of Petitioners, a description of the lands mentioned in the Petition, and the Prayer of the Petitioners, and notified all persons interested in, or who may be affected by such change of the boundaries of the District to appear at the office of the Board at 6640 K.I.D. The Board of Directors of Klamath Irrigation District finds and deems it for the best interests of said District for the reasons set forth in said Petition, including the reasons that said lands were purchased by Petitioner for subdivision and residential housing purposes, to-wit: 5th Addition to Cypress Villa, now known as LOCKFORD DRIVE - TRACT 1228, and will continue to be so used in the future; that said proposed subdivision will have three or more tracts on each acre of land within the subdivision; that it is not feasible to construct adequate irrigation facilities to serve the individual lots as required by ORS 545.611; that said lands are not to be used for agricultural, horticultural, viticultural or grazing purposes and, therefore, said lands hereinafter more particularly described should be excluded from said Klamath Irrigation District pursuant to the provisions of ORS 545.610 and 545.611; and the Board of Directors now being fully advised in the premises.
