Reference is made to that certain trust deed made by D. GONZALES, JAMES I. GONZALES and DEIDRED, as grantor, to TRANSAMERICA TITLE INSURANCE COMPANY, as trustee, in favor of WELLS FARGO REALTY SERVICES, INC., as Trustee under Trust 155, as beneficiary, dated July 15, 1980, recorded November 23, 1981, in the mortgage records of Klamath County, Oregon, in book trust instrument No. M-81 at page 20257, covering the following described real property situated in said county and state, to-wit:

Lot 1, Block 5, Tract Ferguson Mountain Pines, a Subdivision of the W $\frac{1}{2}$ of Section 5, Township 36 South, Range 13 East of the Willamette Meridian, in the County of Klamath, State of Oregon.

Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and a notice of default has been recorded pursuant to Section 86.735(3) of Oregon Revised Statutes; the default for which the foreclosure is made is grantor's failure to pay when due the following sums:

Monthly installments of principal and interest due for the months of September, October, November and December of 1981, January thru December of 1982, January thru December of 1983, January thru December of 1984, January, February, March, April, May, June, and July of 1985 in the amounts of \$17.89 each; and subsequent installments of like amounts; Subsequent amounts for assessments due under the terms and provisions of the Note and Deed of Trust. By reason of said default the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following, to-wit:

\$1,198.19 plus interest and late charges, thereon from August 15, 1981, at the rate of EIGHT AND ONE-HALF (8 $\frac{1}{2}$ %) PER CENT per annum until paid and all sums expended by the Beneficiary pursuant to the terms and provisions of the Note and Deed of Trust.
