THIS AGREEMENT, made and entered into this 5th day of December, 1985, by and between STATE OF OREGON, acting by and through its Board of Forestry, herein called "State," and WEYERHAEUSER COMPANY, a Washington corporation, herein called "Weyerhaeuser," WITNESSETH:

WHEREAS, on the 25th day of May, 1978, State and Weyerhaeuser entered into an Easement Exchange, hereinafter called the "Original Agreement," which was recorded in Volume M78, at page 11354, Records of Klamath County, Oregon, under File No. 49149. Said Original Agreement is hereby supplemented as follows:

State hereby grants and conveys to Weyerhaeuser, its successors and assigns, a permanent, nonexclusive easement upon, over and along a right of way forty (40) feet in width over and across the following described lands in Klamath County, Oregon:

Township 41 South, Range 7 East, W.M.  
~~SW 1/4~~ Section 2

being twenty (20) feet on each side of the centerline of the road located approximately as shown in yellow on the attached Exhibit A.

Subject as to said lands to all matters of public record.

EXCEPT as herein supplemented, all of the terms, conditions and reservations of the Original Agreement shall remain in full force and effect.

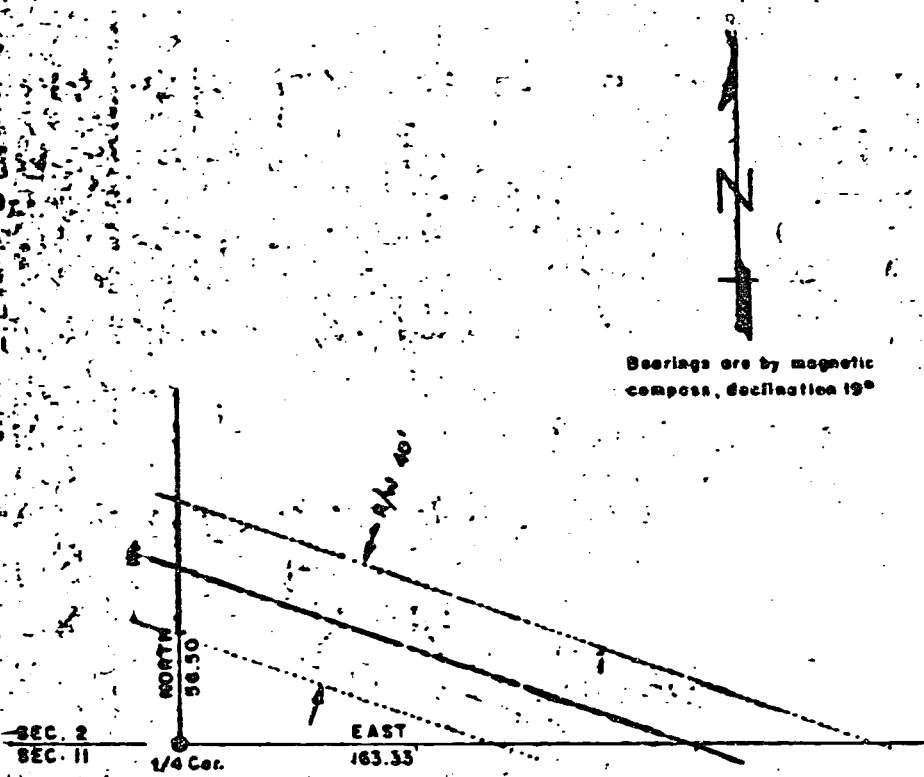
