1. FILL IN THIS FORM

2. Fee of \$3.75 per item listed plus \$2.00 per page when it more than one transaction is to be made on this form and appropriate fee per box, for each transaction.
3. This form is to be filled out by the Debtor(s) and Secured Party(ies) and filed with the filing officer. The Debtor(s) and Secured Party(ies) copies are to be retained by the filing officer.
4. If the space provided for any item(s) on the form is inadequate the form(s) should be continued on additional sheets, size 5" x 8".
