being fifteen (15) feet on each side of the centerline of the existing road located approximately as shown in red on the attached "Exhibit A."

1. The rights herein granted are for the purposes of reconstruction, use and maintenance of said road for the purpose of providing ingress to and egress from lands and facilities now owned or hereafter acquired by OC&E.

2. Grantor reserves for itself, its successors and assigns, the right at all times and for any purpose to go upon, cross and recross, at any place on grade or otherwise, said right of way, and to use said road in any manner that will not unreasonably interfere with the rights granted OC&E hereunder.

3. When either party is the sole user of said road, or any portion thereof, such party shall maintain that portion of said road so used at its sole expense. However, during periods of time when other parties are using the same portion of said road, maintenance shall be in proportion to each party's use.
