WHEREAS, in an action in the United States District Court for the District of Oregon between St. Paul Fire & Marine Insurance Company, plaintiff, and Melvin W. McGrew, aka M. M. McGrew, Olive I. McGrew, aka Olive Pellett McGrew, Northwest McGrew and Nancy D. McGrew, defendants, a judgment was entered on August 23, 1984 for the foreclosure of a mortgage on the real property described below; and
