WHEREAS, the State of Oregon, acting by and through the Economic Development Commission, issued \$2,600,000 Economic Development Commission Bonds, Series I (Maywood Industries of Oregon, Inc. Project), and

WHEREAS, in order to secure the payment of the principal, premium, if any, and interest on the bonds according to their tenor and effect and to secure the performance and observance by the State of Oregon, acting by and through the Economic Development Commission, of all the covenants expressed or implied in the bonds, granted to the First National Bank of Oregon as trustee, and its successors in trust and assigns forever, a security interest in the Lease with all rights to make claim for collection and receipt of the rents, income, revenues, issues and profits and other sums of money payable or receivable thereunder.

NOW, THEREFORE, the First National Bank of Oregon as the holder of the Mortgage and Indenture of Trust does hereby certify and declare that the Mortgage and Indenture of Trust, bearing the date as of April 1, 1976, made and executed by the First National Bank of Oregon as trustee, and the State of Oregon, acting by and through the Economic Development Commission, recorded in the office of the County Clerk of the County of Klamath, State of Oregon, in Mortgage Records Book No. 12773 on the 21st day of April, 1976, is fully paid, satisfied and discharged.


