WARRANTY DEED—TENANTS BY ENTIRETY

KNOW ALL MEN BY THESE PRESENTS, That  
JOHN KETARKUS and DORIS T. KETARKUS  
hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by FRANK A. GREEK and CATHY E. GREEK, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lots 4, 5 and 6 in Block 4 of KLAMATH RIVER SPORTSMAN'S ESTATES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO: Release of Claim for Damages recorded December 22, 1931, in Volume 96 page 440, Deed records of Klamath County, Oregon; easement and right to raise and/or lower water level of Klamath River between elevations of 4085 to 4086.5 feet above sea level, recorded December 22, 1931, in Volume 96 page 441, Deed records of Klamath County, Oregon; reservations and restrictions contained in the dedication of Klamath River Sportsman's Estates; deed restrictions, covenants and conditions for Klamath River Sportsman's Estates, recorded May 6, 1968, in Volume M68 page 4084, Deed records of Klamath County, Oregon.

To Have and to Hold the above described and granted premises unto the said grantees, as tenants by the entirety, their heirs and assigns forever.

And grantor hereby covenants to and with grantees and the heirs of the survivor and their assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 7,310.67
