GUNNARSON, married man, as sole and separate property PIONEER NATIONAL TITLE INSURANCE CO., as grantor, to in favor of WELLS FARGO REALTY SERVICES, INC., A California Corporation, as trustee, dated January 26, 1977, recorded February 16, 1977, in the mortgage records of Klamath County, Oregon, in book/entry No. M-77 at page 2827, from this instrument, microfilm, or otherwise, covering the following described real property situated in said county and state, to-wit:

Lot 21, Block 19, FIRST ADDITION TO FERGUSON MOUNTAIN PINES, in the County of Klamath, State of Oregon.

Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and a notice of default has been recorded pursuant to Section 86.735(3) of Oregon Revised Statutes; the default for which the foreclosure is made is grantor's failure to pay when due the following sums: Monthly installments of principal and interest due for the months of June, July, August, September, October, November and December of 1983, January thru December of 1984, and January, February, March, April, May, June and July of 1985 in the amounts of \$17.53 each; and subsequent installments of like amounts; Subsequent amounts for assessments due under the terms and provisions of the Note and Trust Deed.

By reason of said default the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following, to-wit: \$479.71 plus interest and late charges, thereon from August 10, 1983, at the rate of EIGHT AND ONE HALF (8½%) PER CENT per annum until paid and all sums expended by the Beneficiary pursuant to the terms and provisions of the Note and Deed of Trust.

WHEREFORE, notice hereby is given that the undersigned trustee will on April 22, 1986, at the hour of 10:00 o'clock, A.M., Standard Time, as established by Section 187.110, Oregon Revised Statutes, at ASPEN TITLE & ESCROW, INC., 600 Main Street in the City of Klamath Falls, County of Klamath, State of Oregon, sell at public auction to the highest bidder for cash the interest in the said described real property which the grantor had or had power to convey at the time of the execution by him of the said trust deed, together with any interest which the grantor or his successors in interest acquired after the execution of said trust deed, to satisfy the foregoing obligations thereby secured and the costs and expenses of sale, including a reasonable charge by the trustee.
