1. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal + that are next due on the note, on the first day of any month prior to maturity: Provided, however, That written notice of an intertion to. exercise such privilège is given at least thirty (30) days prior to prepayment.

2. Grantor agrees to pay to Beneficiary in addition to the monthly payments of principal and interest payable under the terms of said note, on the first day of each month until said note is fully paid, the following sums:

6.
