6. Granting to MYX the full power and authority to do and perform all and every act and thing which may be required, necessary and proper to be done in the exercise of any of the rights and powers herein granted, as fully as if he were and appears as, I, might or could do if personally present, with full power of attorney in that behalf to be done by MYX, and confirming all that MYX attorney in fact, or attorneys in fact, shall lawfully do or cause to be done by virtue of this power of attorney and the powers herein granted;

7. That I hereby authorize and empower MYX to execute and deliver this power of attorney, the execution of which shall not be deemed an admission of any fact, and is not to be construed or interpreted as limiting or restricting any special powers herein granted to MYX attorney in fact;

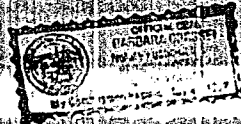
