KNOW ALL MEN BY THESE PRESENTS, That PADDOCK REAL ESTATE CO., an Oregon corporation hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by RALPH A. CRAWFORD CO., an Oregon corporation, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

The West half of Lot 13 in Block 2 of Bryant Tracts No. 2 according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

This deed is given to correct the legal description in that certain deed from above grantor to above grantee recorded September 17, 1981, Vol. M81, page 16502.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
