- 1. The debt secured by this instrument shall include not only the Note recited above but also any assistance paid by the Secretary in accordance with Section 235 of the National Housing Act on behalf of any party to the deed of trust (including any party who takes title to the property subject to the said Deed of Trust or assumes said Deed of Trust) identified as FHA Case No. 431-1711045 (Insured Deed of Trust).
- The debt will be due and payable when the first of the following.
 - (a) Title to the Property is conveyed to a party who is not eligible for Section 235 mortgage assistance payments, or-
 - (b) The property covered by the Insured Deed of Trust is rented for a period longer than one year.
- 3. If the Insured Deed of Trust is not paid in full when payment is due under paragraph 2, the Secretary may defer payment until the Insured Deed of Trust is paid in full. If payment is deferred, the debt will bear interest at the rate of 9.5 percent per year from the date the debt is due under paragraph 2 until the full amount of the debt and interest is paid.
