SHORT FORM DEED

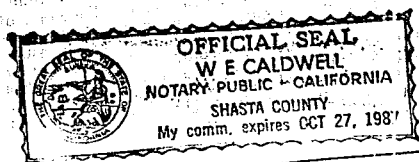
The Fictitious Deed of Trust mentioned hereinabove was recorded in Solano County on May 3, 1976.
