Reference is made to that certain trust deed made by SCOTT W. ENGLISH and JUNE E. ENGLISH, husband and wife, as grantor, to TRANSAMERICA TITLE INSURANCE COMPANY, A California Corporation, as trustee, in favor of WELLS FARGO REALTY SERVICES, INC., A California Corporation, as beneficiary, dated March 12, 1979, recorded July 13, 1979, in the mortgage records of Klamath County, Oregon, in book/~~827-28~~ Page No. M-79 at page 16553, covering the following described real property situated in said county and state, to-wit:

Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and a notice of default has been recorded pursuant to Oregon Revised Statutes 86.735(3); the default for which the foreclosure is made is grantor's failure to pay when due the following sums: Monthly installments of principal and interest due for the months of August, September, October, November, and December of 1985, and January of 1986, in the amounts of \$69.16 each; and subsequent installments of like amounts; Subsequent amounts for assessments due under the terms and provisions of the Note and Trust Deed.

By reason of said default the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following, to-wit: \$2,178.18 plus interest and late charges, thereon from July 16, 1985, at the rate of EIGHT (8%) PER CENT PER ANNUM until paid and all sums expended by the Beneficiary pursuant to the terms and provisions of the Note and Deed of Trust.
