This deed confirms a certain deed dated April 3rd, 1917, executed by my late husband, P. A. Hyde, and myself.

It was the intent of said prior deed to transfer all property and rights, whether situated and accruing in California, or in other States, and this present deed is executed to permit the addition to the acknowledgment of certain words and declarations required in other States.
