KNOW ALL MEN BY THESE PRESENTS, That Joann Passe, Personal Representative for The Estate of Ferdinand Thomas Sheridan

hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by John M. Cochran and Elizabeth J. Cochran, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lot 9, Block 18, KLAMATH RIVER ACRES SECOND ADDITION, in the County of Klamath, State of Oregon. SUBJECT TO:

1. Conditions, restrictions as shown on the recorded plat of Klamath River Acres Second Addition.
2. Any improvement located upon the insured property, which constitutes a mobile home as defined by Chapter 481, Oregon Revised Statutes, is subject to registration and taxation as therein provided and as provided by Chapter 308, Oregon Revised Statutes.
3. A 20 foot building set back line from streets as reserved in plat dedication.

And grantor hereby covenants to and with grantees and the heirs of the survivor and their assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except easements, covenants and restrictions of record referred to above and those apparent on the land.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

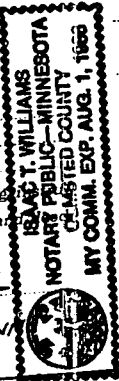
