CONSENT AGREEMENT

WHEREAS the United States of America, hereinafter called the Government, has an interest in the real property hereinafter described by virtue of the following right-of-way easement deeds dated 6 March 1964, and recorded 11 March 1964, in Volume 351, Page 484; dated 10 April 1964, and recorded 14 April 1964, in Volume 352 Page 304; dated 26 October 1964, and recorded 2 November 1964 in Volume 357, Page 313, in the records of Klamath County, Oregon, and which easements traverse the following described real property in the County of

Government Lot 17, Section 28, Township 35 South, Range 7 East, W.M. N2SW4SW4NW4, Section 27, Township 35, South, Range 7 East, W.M. Government Lot 16, Section 28, Township 35 South, Range 7 East, W.M.

WHEREAS, Telephone Utilities of Eastern Oregon, Inc., hereinafter called the Corporation, has need to construct, operate, and maintain an underground telephone cable and the necessary appurtenances thereto within the Government's easement.

NOW THEREFORE, The Government consents to the construction, operation, and maintenance of said cable and appurtenances within the Government's easement, subject to the following conditions:

1. Construction will be in accordance with construction drawings submitted to and on file with the Government in Klamath Falls, Oregon.

2. The Corporation shall repair all damage to National Forest roads caused by the Corporation in the construction, operation, and maintenance of said cable and appurtenances.

3. This agreement is executed with the express understanding that should future location of Government's road require the relocation of the Corporation's cable and appurtenances, such relocation will be done by the Corporation at its expense within sixty (60) days following a written request to relocate.

4. The Corporation shall indemnify and hold harmless the Government against all claims or liabilities for damage to life or property arising from the Corporations acts or ommissions in the construction, operation, and maintenance of said telephone cable and appurtenances.

5. This Consent Agreement is issued on the condition that the Corporation has secured, or will secure, the consent of any person having claim to the land.
