# Notice of Location of Placer Claim

NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 160 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the Sumago S.E. #48 (forty-eight) Claim, which is described as follows (fill out one of the two sections below):

If claim is on surveyed land:

This claim comprises the Southwest Quarter (excluding governmental) of Section 6 (Six), Township 32 South, Range 7 East, of the Willamette Meridian, in the State of Oregon. The location post stands alongside road #550 just Northeast of the point where it intersects the East-West survey line between sections 6 and 7.
