1 KNOW ALL MEN BY THESE PRESENTS that Henry R. Jarrard and Dorothy Jarrard,  
 2 Assignors, in consideration of Ten Dollars and other good and valuable considera-  
 3 tions to them paid by KLAMATH FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION,  
 4 Assignee, do by these presents sell, transfer and assign unto Assignee all of  
 5 Assignors' interest in and to that certain real property contract dated May 30,  
 6 1986, wherein Assignors agreed to sell and Allie M. Bray agreed to purchase the  
 7 following-described property in Klamath County, Oregon:

8 Beginning at the Northeast corner of Tract 32 of Altamont Small Farms,  
 9 thence North 88°46' West along the Northerly line of said tract 200  
 10 feet; thence South 0°11' West 452 feet, more or less, to the Northeast-  
 11 erly line of the right of way of the Great Northern Ry. as more parti-  
 12 cularly described in deed recorded Volume 95 of Deeds at page 278,  
 13 Records of Klamath County, Oregon; thence Southeasterly along the North-  
 14 erly line of said right of way 260 feet, more or less, to the Easterly  
 15 boundary of Tract 31, Altamont Small Farms; thence along the Easterly  
 16 boundary of said Tracts 31 and 32, North 0°11' East 610 feet, more or  
 17 less, to point of beginning, containing 2.46 acres, more or less, and  
 18 being the Easterly 200 feet of that portion of Tracts 31 and 32 of  
 19 Altamont Small Farms lying Northeasterly from the right of way of the  
 20 Great Northern Railway;

21 and which said contract and deed are escrowed at Klamath First Federal Savings  
 22 and Loan Association, Klamath Falls, Oregon.

23 Assignors further, in consideration of the foregoing, convey unto Assignee  
 24 all of their right, title, estate and interest in and to said property subject  
 25 to the terms and provisions of said contract.

26 TO HAVE AND TO HOLD the same unto Assignee, its successors and assigns  
 27 forever.

28 PROVIDED, HOWEVER, that it is expressly understood and agreed that this  
 29 Assignment is executed as collateral security for the payment of that certain  
 30 promissory note dated June 20, 1986, in principal amount of \$18,900.00, executed  
 31 by the Assignors as makers to the Assignee as payee, which said note provides  
 32 for future advances and any and all extensions and renewals thereof, and this  
 assignment shall be void when, and if said note is paid in full, but until such  
 time as the said note is paid in full, Assignee shall be deemed the sole owner  
 of said contract and the property covered thereby and shall be free to collect  
 all of Assignors' share of the proceeds therefrom, and Assignee may sell, assign  
 or otherwise dispose of said contract and/or said property and any interest therein;  
 and may foreclose said contract for breach thereof or accept a deed to said property
