C.R. and Carol Helt have been found in violation of the 1 Klamath County Land Development Code based on the following 2 Findings of Fact: 3 1. The property is located in the Merrill Tracts, off 4 Falvey Road in the Merrill Urban Growth Area. It is 140 feet by 5 6 100 feet and rectangular in shape. 7 2. The Planning Department first received a complaint on August 12, 1985. Promises were made by the Helts to clean up 8 the violation by May 12, 1986; however, a subsequent inspection 9 10 indicated that this was not done. 11 3. The violation concerns the accumulation of inoperable/ wrecked vehicles and parts at the Helt property which is west of 12 13 Merrill. See the photograph, Exhibit "D", herein. 14 4. Notice of this hearing was sent to the surrounding 15 property owners, to concerned public agencies and published in 16 the Herald & News, the Klamath Falls newspaper. 17 5.
