KNOW ALL MEN BY THESE PRESENTS, That Willie Sowers

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by alice C. Hawey & Patty C. Millett, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 10 and the southeasterly 15 feet of lot 11 in block 17 of industrial addition to the city of Klamath Falls, according to the official plat thereof on file in the office of the County clerk of Klamath County, Oregon. The whole being a rectangular piece of land 40 feet wide & 115 feet long, facing 40 feet on East Main St.
