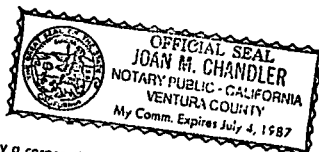
KNOW ALL MEN BY THESE PRESENTS, that MICHAEL L. BECK and SUSAN L. BECK,
