NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 80 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the Sunago SE #38 (thirty-eight) Mining District.

(1) If claim is on surveyed land:

This claim comprises the South 1/2 (half) of the Southeast Quarter of Section 14 (fourteen) Township 32 South, Range 7 1/2 East, of the Willamette Meridian, in the State of Oregon. The location notice post stands on the East side of road 2303, approx. 0.2 miles Northeast of its junction with road 2303.
