# Notice of Location of Placer Claim

NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 16.0 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the Sumago SE #54 (Fifty-Two)

This claim comprises the West 1/2 (half) of the East 1/2 (half) (excluding land withdrawn) of Section 31 (thirty-one) Township 31 South, Range 7 East, of the Williamette Meridian, in the State of Oregon. The location notice post stands near the junction of roads O.B.O. and O.B.U. on the West side of the old Indian reservation boundary.
