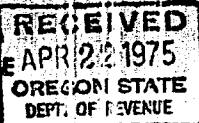

- 2 - Deficiency due to negligence; 5%
- 3 - Failure to file; 5% per mo.; maximum 25%

2) Interest

a) 1968 and prior years:

- 1 - Delinquency or deficiency; 1/2 of 1%
- 2 - Failure to file; 1/2 of 1%
- 3 - Delinquent instalment; 1% + 1/2 of 1%

b) 1969 and later:

- 1 - Delinquency or deficiency; 2/3 of 1%
- 2 - Failure to file; 2/3 of 1%
- 3 - Delinquent instalment; 1% + 2/3 of 1%
