Section A. Change in Trust Composition

EASTWOOD, of Tormance, California shall replace and succeed him or her as Co-Trustee and shall carry out the terms and provisions of this Trust as set forth herein.

The **Trustee** shall use his or her best effort to collect all sums **payable** on contracts of insurance on the life of **Trustor**.
