KNOW ALL MEN BY THESE PRESENTS, That Transamerica Financial Services, a corporation v. M86 page 15681

Lot 5 in Block 13 of Sixth Addition to Sunset Village according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to easements and rights of way of record and apparent on the land and to Turst Deed in favor of Klamath First Federal Savings and Loan Association recorded March 26, 1976, Vol. M76, page 4306, Mortgage Records of Klamath County, Oregon, which grantees assume and agree to pay.
