The Mortgagor does hereby covenant and agree to and with the Mortgagee, its successors and assigns:

- 1. That Mortgagor will pay, when due, the indebtedness hereby secured, with interest, as prescribed by said note, and all taxes, liens and utility charges upon said premises or for services furnished thereto.
- 2. That Mortgagor will keep the real and personal property hereinabove described in good order and repair and that if any of the said property than the value thereof at the time of such loss or damage; provided, that if such loss or damage shall be caused by a hazard against which insurance is carried, the obligation of the Mortgagor to repair or reconstruct shall not arise unless the Mortgagoe shall consent to the application of insurance proceeds to the expense of such reconstruction or repair.
