AN ORDINANCE VACATING THE ALLEY RIGHT-OF-WAY
LYING IN BLOCK 3, SIXTH STREET ADDITION TO
THE CITY OF KLAMATH FALLS.

WHEREAS, The City Planning Commission, pursuant to a public hearing on December 30, 1985, did recommend the Common Council grant the proposed vacation; and

WHEREAS, on February 3, 1986, the Common Council held a public hearing on a proposal to vacate the alleyway lying in Block 3 of Sixth Street Addition to the City of Klamath Falls; and

WHEREAS, The Common Council has determined that it is in the best interest of the City of Klamath Falls that said alleyway be vacated;
NOW, THEREFORE,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

That dedicated alleyway lying in Block 3, Sixth Street Addition to the City of Klamath Falls as shown as the official plat thereof on file in the office of the County Clerk for Klamath County, Oregon, and according to the map attached hereto, and incorporated as Exhibit "A" is hereby vacated.

Section 2.

The City of Klamath Falls, Oregon, hereby reserves unto itself an exclusive utility easement sixteen (16) feet wide, over, under and across that portion of the alley in Block 3, Sixth Street Addition that is vacated by this ordinance. The easement is for the purpose of constructing, operating, maintaining, relocating, removing and/or replacing a sanitary sewer pipeline, and necessary or desirable appurtenance thereto, and is described as follows:

A strip of land sixteen (16) feet wide, lying eight (8) feet on each side of the centerline of the alley in Block 3 of Sixth Street Addition to the City of Klamath Falls, Oregon; said strip of land beginning at the north line of said Block 3 and running south to the northerly right of way line of Pershing Way.

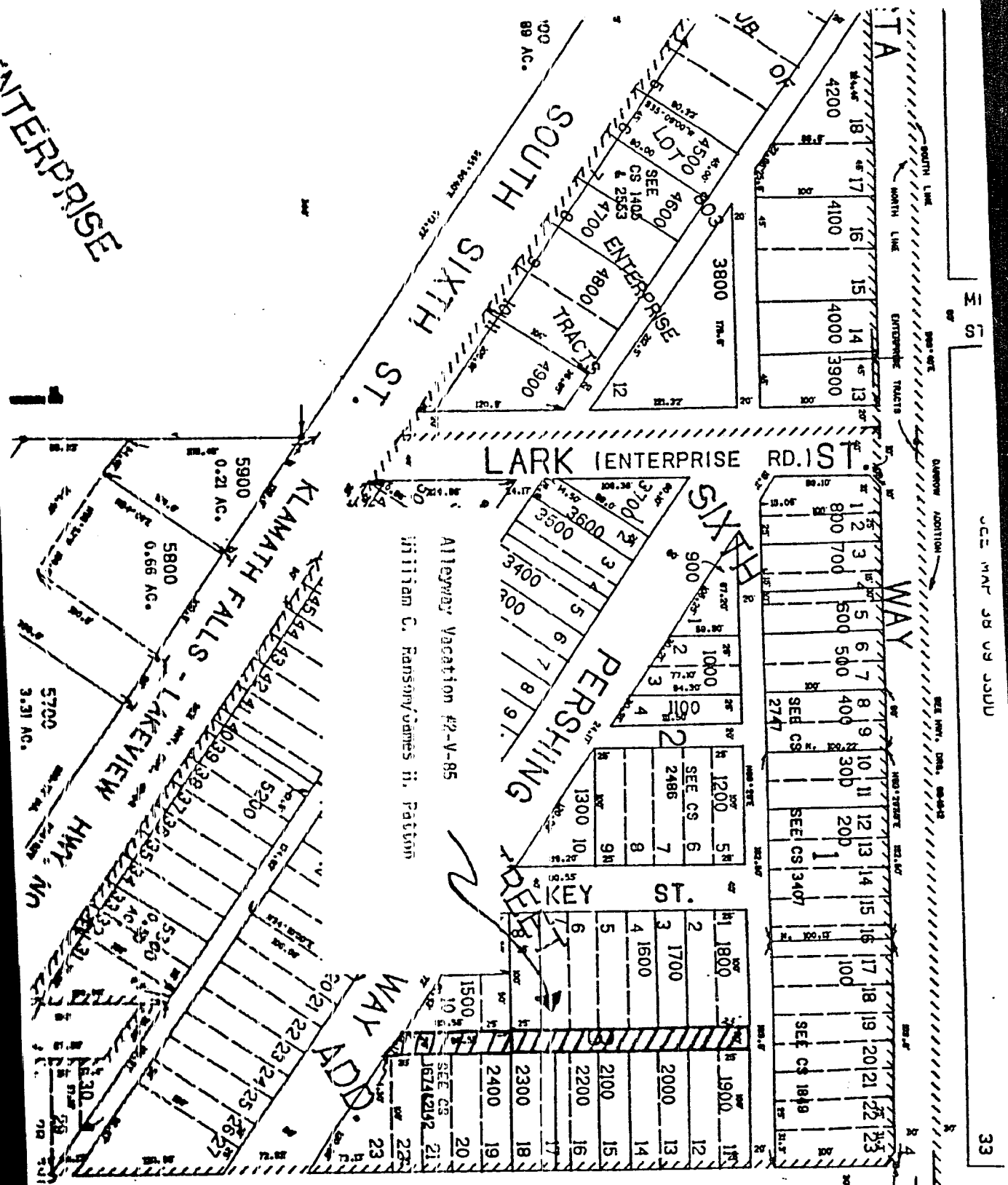
