WHEREAS, the City Planning Commission, pursuant to a public hearing on May 14. 1984, did recommend the Common Council grant the proposed vacation; and,

WHEREAS, as on June 13, 1984, the Common Council held a public hearing on a proposal to vacate the portions of the streets located in Admiral Court subdivision of the City of Klamath Falls, more particularly described as that portion of Radcliffe Avenue East of Washburn Way; all of Turnage Avenue; all of Halsey; all of Nimitz; and all of Vandergrift Avenue; and,

WHEREAS, as a result of the hearing held on June 18, 1984, the Common Council has made FINDINGS and included as exhibit B, attached hereto and incorporated herein by this reference determining the vacation to be in compliance with the Community Development Ordinance, the City's Comprehensive Plan and the State-wide Land Use Goals and Guide lines; and,

WHEREAS, the Commom Council has determined that it is in the best interest of the City of Klamath Falls that said streets be vacated; NOW, THEREFORE,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

The dedicated portion of streets in the Admiral Court subdivision of the City of Klamath Falls consisting of that portion of Radcliffe East of Washburn Way; all of Turnage Avenue; all of Halsey; all of Nimitz; and all of Vandergrift Avenue as shown on the official plat thereof on file in the office of the County Clerk for Klamath County, Oregon, and according to the map attached hereto, and incorporated as exhibit "A" is hereby vacated.
