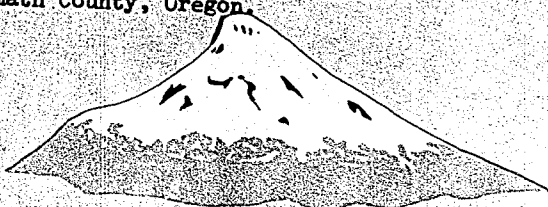


KNOW ALL MEN BY THESE PRESENTS, That ELMER C. KUNZE and JOAN E. KUNZE, husband and wife

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except those of record and those apparent upon the land, if any, as of the date of this deed

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 32,500.00

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that the whole of the above described premises shall be conveyed unto the said grantee and grantee's heirs, successors and assigns, free from all encumbrances except those of record and those apparent upon the land, if any, as of the date of this deed.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
