A term special use permit issued by the U. S. Department of Agriculture, acting through its Forest Service, and

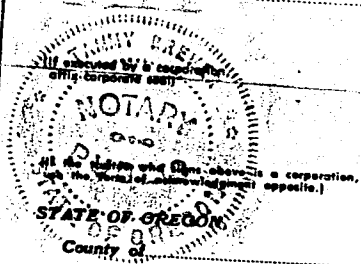
