NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 160 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. thence 1320 feet in a West direction to a post marked No. 3;
thence 1320 feet in a South direction to a post marked No. 4;
thence 1320 feet in a South direction to a post marked No. 5;
thence 1320 feet in a East direction to a post marked No. 6;
thence 1320 feet in a East direction to a post marked No. 7;
thence 1320 feet in a North direction to a post marked No. 8;
thence 1320 feet in a North direction to the post marked No. 1.

This claim is situated in all of the (quarter sections of Section 14 (fourteen), Township, 32 South, Range 6 East, of the Willamette Meridian, as shown on the location notice post stands just Southwest of Post #1, as referred to above.

The locators intend to hold and work the above described claim as provided by the laws of the United States and the State of Oregon and claim all of the rights and privileges granted by existing laws and customs.
